# Rules and Policies

## Application Process

**Applications are accepted during normal business hours.**

Application fee deposits are non-refundable and required for all rentals at the time of application. If the cost of the rental is less than the application fee deposit, the full rental fee will be due at the time of application and will also be non-refundable. The individual or representative of an organization wishing to cancel must do so in writing within 24 hours of the scheduled usage for a refund to be considered.

## Availability

- The facilities at this complex are available to rent during times when they are not scheduled for program or community service use. Facilities must be rented for a minimum of two hours. Additional staff fee will be applied as needed.

## Fees

## Payment

Payment may be made by cash, check (made payable to City of St. Petersburg), or credit card.

## Additional Information

- **Flotation Devices** - Only Coast Guard approved flotation devices may be used in the pool (no water wings).
- **Swim Diapers** - Swim diapers are required. Two swim diapers must be worn by children not toilet trained.
- **Alcoholic Beverages** - Alcoholic beverages are not allowed at the pool or in public parks.
- **Smoking** - Smoking is not permitted.
- **Glass Containers** - Glass containers are not allowed on the pool decks.
- **Animals** - Animals of any kind are not allowed at the pool, except service animals that are trained to provide assistance for an individual with a disability.
- **Lightning** - Patrons must remain out of the pool for 30 minutes after the pool is cleared due to lightning.
- **Refunds** - Refunds or rain checks will not be issued to patrons in the event of natural causes or other emergency situations that may require the pool to close.
- **Water Slides** - No tubes, or life jackets are permitted on the water slide. Non-swimmers are not permitted on the slide. Parents may NOT hold children on the slide.
